- 1. Registration can only be made using this form and should be supported by photos and/or a web link.
- 2. Participation only becomes legally binding upon written confirmation/acceptance by the organizer.
- 3. Set-up: on 04.05.2024 between 10:00 and 13:30.
- 4. Direct access to the market is restricted. Please access via Thomasgasse (the bollards are raised from 10:00 am). Then it is best to continue on foot. In individual cases we can lower the bollards, please let us know in advance.
- 5. **Electricity use must be indicated as clearly as possible in advance.** Please bring a labeled cable drum. There will be distribution boxes at intervals which you can use.
- 6. No stand fee will be charged. Nevertheless, we are happy to receive donations (e.g. between €10.00 and €30.00) to help cover our expenses. It is possible to issue a donation receipt. Please provide us with your full address so that we can issue it.
- 7. The stand host is responsible for the order, cleanliness and safety in her area.
- 8. All stands offering cleaning products, cosmetics, food, etc. must contact the Health Department of the City of Leipzig in advance.
- 9. **Freelance traders need their sales licence/market permit to sell their goods**. Anyone who wants to sell something as private person can also do so, as long as the sale at the Frauen*/FLINTA*-Festival is a **one-off** sale in 2024. Please let us know in advance if this is your case.
- 10. The offering of the following articles is strictly prohibited:
 - Animals
 - Weapons, war toys, articles from the NS period,
 - Articles glorifying violence / extremist content
 - Articles that violate customs and copyright laws
- 11. It would be great if you could come up with a hands-on activity to get in touch with visitors of the festival. (Quizzes, skill tests, puzzles, creative activities, etc.)
