2. Participation only becomes legally binding upon written confirmation/acceptance by the organizer.
3. Set-up: on 30.05.2026 between 10:00 and 13:30.
4. Direct access to the market is restricted. Please access via Thomasgasse (the bollards are raised from 10:00 am). Then it is best to continue on foot. In individual cases we can lower the bollards, please let us know in advance.
5. **Electricity use must be indicated as clearly as possible in advance.** Please bring a labeled cable drum. There will be distribution boxes at intervals which you can use.
6. The stand host is responsible for the order, cleanliness and safety in her area.
7. **All stands offering cleaning products, cosmetics, food, etc. must contact the Health Department of the City of Leipzig in advance.**
8. **Freelance traders need their sales licence/market permit to sell their goods.** Anyone who wants to sell something as private person can also do so, as long as the sale at the Frauen\*/FLINTA\*-Festival is a **one-off** sale in 2026. Please let us know in advance if this is your case.
9. The offering of the following articles is strictly prohibited:
  - Animals
  - Weapons, war toys, articles from the NS period,
  - Articles glorifying violence / extremist content
  - Articles that violate customs and copyright laws
